

MINUTES OF THE REGULAR ANNUAL MEETING  
OF THE BOARD OF DIRECTORS  
AND MEMBERS OF K.C. ELECTRIC ASSOCIATION

A regular annual meeting of K.C. Electric Association was held in Flagler, Colorado on Thursday June 1, 2017 at the hour of 7:00 p.m.

Welcome: The members were welcomed and the meeting was called to order by President Kevin Penny.

Pledge of Allegiance and National Anthem: The membership was led in the Pledge of Allegiance and National Anthem sung by Barb Rueb.

Introduction of Directors: Mr. Penny introduced the directors of K.C. Electric, Vice President Dan Mills, Secretary/Treasurer Wayne Parrish, Assistant Secretary/Treasurer Dave Ritchey, Director Jim Michal, Director Terry Tagtmeyer, Director Marvin Thaller, Director Luanna Naugle, Director Robert Bledsoe, and himself, President Kevin Penny.

Introduction of Employees: Mr. Penny asked K.C. employees to assemble in front of the crowd for introductions. Mr. Churchwell introduced the employees and Mr. Penny presented a Board resolution of appreciation to the employees for their exemplary service in restoring power after the March 24 storm.

Quorum: Mr. Penny reported 103 members were in attendance and that a quorum had been met.

Proof of Publication: Mr. Penny requested a motion to dispense with the reading of the Proof of Publication. Upon a motion and a second, the following resolution passed:

“BE IT RESOLVED: That the reading of the Proof of Publication is hereby dispensed with and the assembly does hereby accept and approve such.”

Approval of Minutes: Mr. Penny requested a motion to approve the minutes as mailed. Upon a motion and a second, the following resolution passed:

“BE IT RESOLVED: That the Minutes of the Regular Annual Meeting of the Board of Directors and Members of K.C. Electric Association held on Thursday, June 2, 2016 in Stratton Colorado at 7:00 p.m. are hereby approved.”

Introduction of Nominees: Mr. Penny informed the assembly there were no contested races for the Board election this year. K.C. attorney Mr. Jeff Cure explained K.C. bylaw 3.1(g) which specifies if the number of qualified candidates nominated for election as a director in each district is less than or equal to the number of vacancies in each district, then the election of directors shall automatically be dispensed with and the nominees shall be deemed elected. Mr. Cure explained K.C.’s Board Election Policy including the election committee, election process, ballot procedure, and ballot tabulation.
